## National Workers' Comp Defense Firm Earns Top Ranking from Law360

**NEW YORK, July 26, 2017** – *Law360*, a leading publication covering law firms and legal developments, has ranked Adelson, Testan, Brundo, Novell & Jimenez (ATB) as the country's top law firm for percentage of female equity partners. At ATB, women attorneys comprise 60 percent of the firm's equity partners, the highest percentage of female equity partners of the over 300 law firms participating in *Law360's* 2017 *Glass Ceiling* study.

In compiling the 2017 *Glass Ceiling* report, *Law360* surveyed more than 300 U.S. firms, or vereins with a U.S. component, about their overall and female headcount numbers as of Dec. 31, 2016. Only U.S.-based attorneys were included in the survey, and firms were required to have at least 20 U.S.-based attorneys to participate. Law firms were ranked based on their percentage of U.S. equity partners that identify as women.

According to *Law360*, firms not disclosing equity partnership gender data were ineligible for the ranking.
